<sup>1</sup> After December 31, 2022, the Tesla model Y is no longer eligible to receive a rebate due to the vehicle not meeting program requirements. Any completed vehicle purchases or leases for eligible vehicle models (2020-2022 model years) prior to January 1, 2023 will be honored with the rebate. The vehicle **purchase date is based on the first date of registration**, so to qualify for the rebate, first date of registration (odometer date) must be on or before December 31, 2022.
