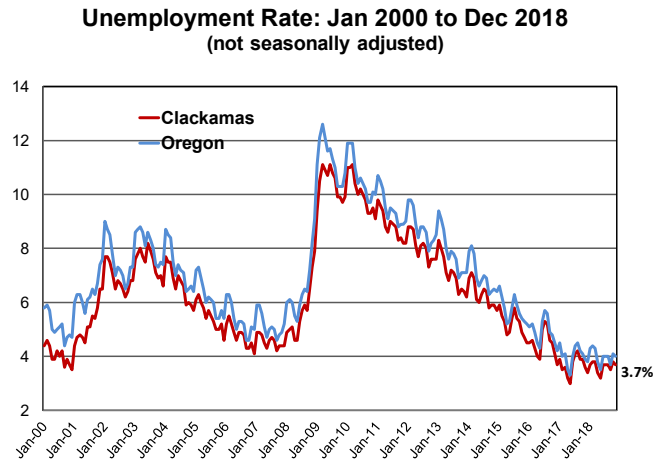
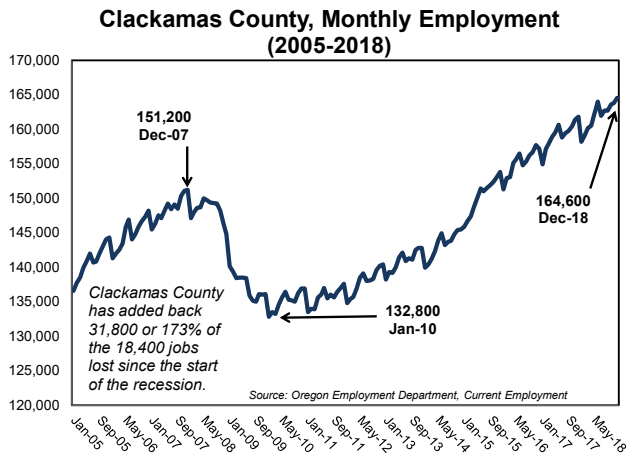
ECONOMIC INDICATORS

The employment level in Clackamas County reached 164,600 in December.

Unemployment rate kept steady in December from previous month.



Location Quotients and the Unique Industry Makeup in the Portland Tri-County Area

Location Quotients (LQ's) are ratios that show how concentrated a particular industry is in a region as compared to the nation. Industry LQ's are calculated by comparing the industry's share of regional employment with its share of national employment. An LQ greater than 1 indicates an industry with a greater share of the local area employment than is the case nationwide. The most recent LQ estimates show that Clackamas County has the highest relative concentrations in agriculture, construction, wholesale trade, other services, manufacturing, and retail trade. Multnomah County's highest ratios are in other services, transportation and warehousing, private education, real estate, professional and technical services, and information. Washington County has its highest relative concentrations in management of companies and enterprises, manufacturing, and information.
