Employment in Yamhill County: November 2020

Yamhill County's Unemployment Rate Declines to 5.1%

Yamhill County's seasonally adjusted unemployment rate was 5.1% in November, down from its revised rate of 5.8% in October. Oregon's statewide unemployment rate in November was 6.0%, down from its revised October rate of 6.8%.

Yamhill County's employment losses in November were larger than normal; total nonfarm employment decreased 350 jobs, when an employment decline of 190 jobs would be expected. As a result, seasonally adjusted employment declined 160 between October and November. Employment remains 9.4%, or 3,300 jobs, below the level in February, after sharp job losses in the spring.

Manufacturing (-170 jobs, -2.6%), construction (-70, -3.5%), and leisure and hospitality (-70 jobs, -2.5%) were the three industries in the private sector showing the largest employment declines in November.

The private-sector industries adding employment in November were: retail trade (+30 jobs, 0.8%), health care and social assistance (+30, 0.6%), and information (+10, 4.2%).

Yamhill County's public sector shed 30 jobs in November. Those losses all occurred in local government.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence.

Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants.

Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
