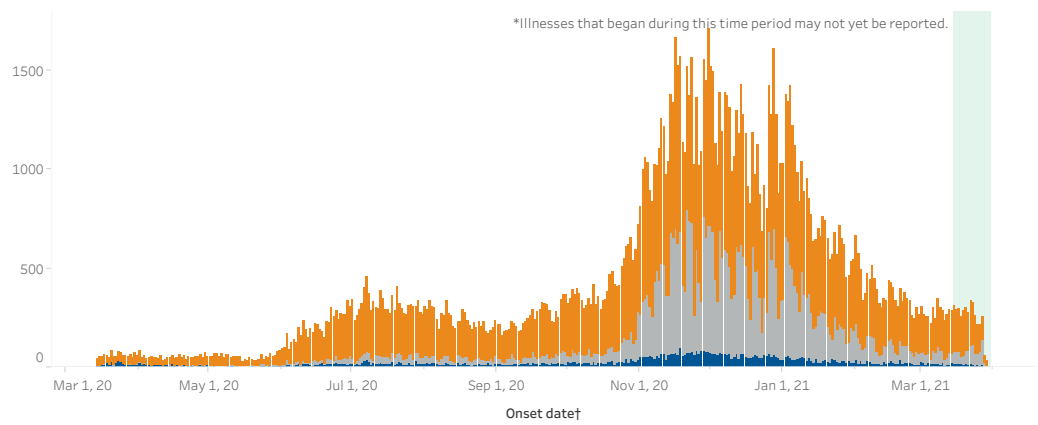

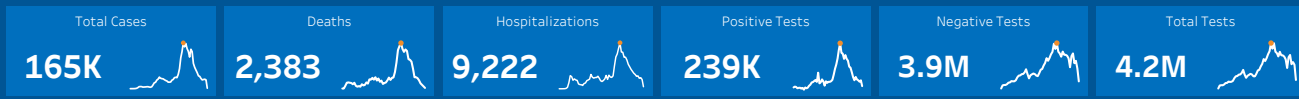
Please note: The light blue shaded area shows the past 17 days, and not all people who got sick during this time period have been reported yet to OHA.

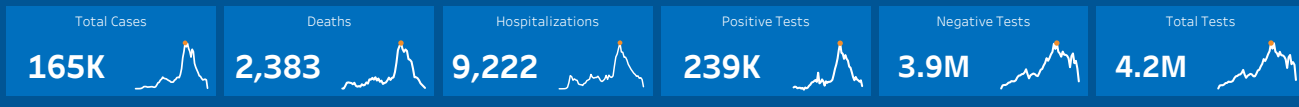

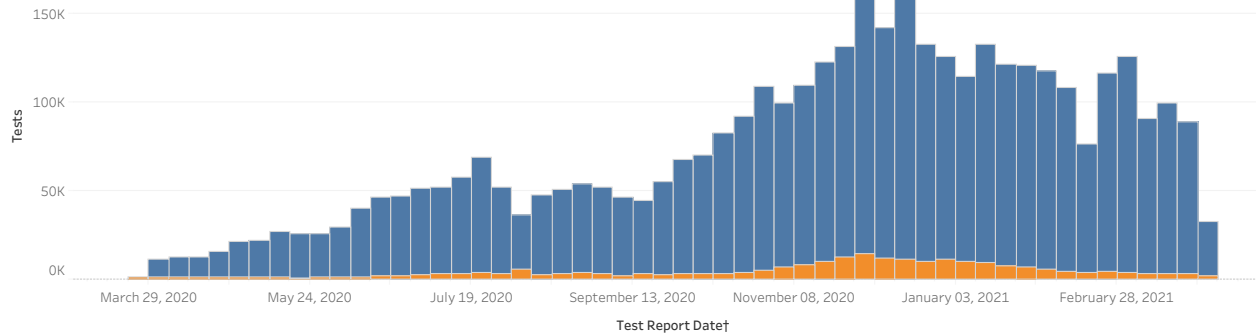

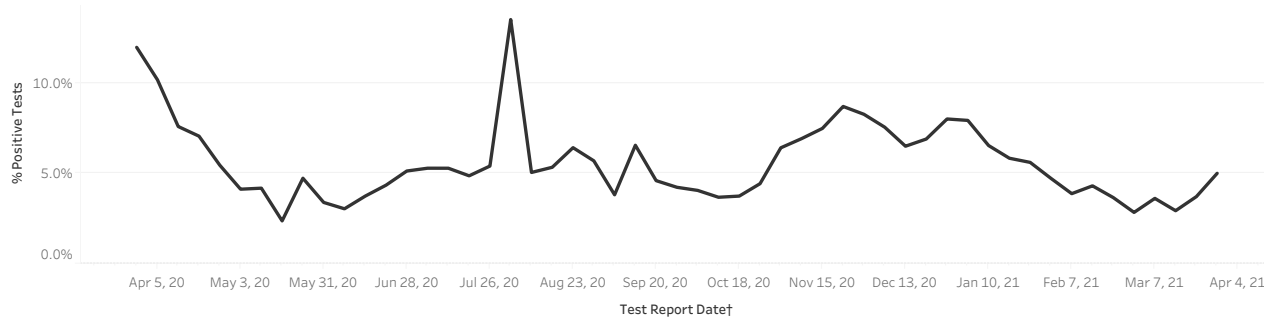
